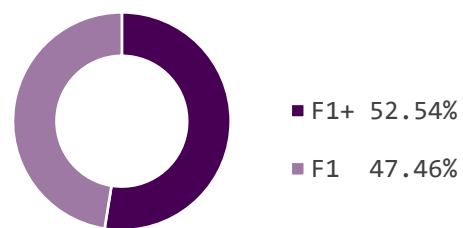

Fund risks
