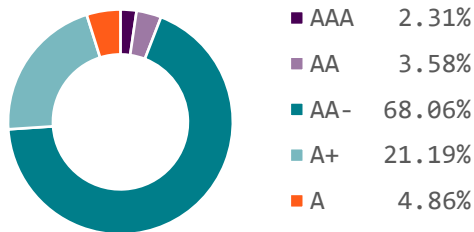

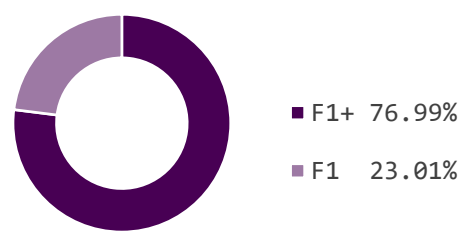

## Fund risks
