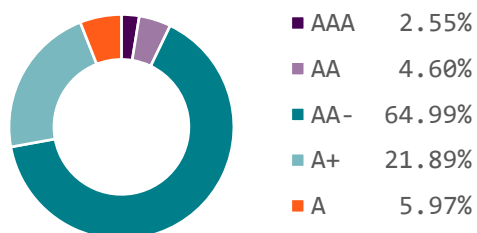

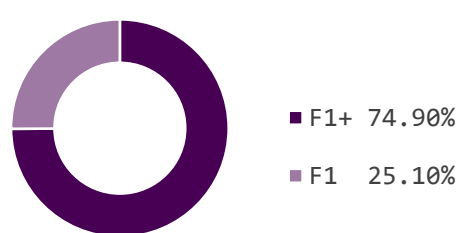

Fund risks
