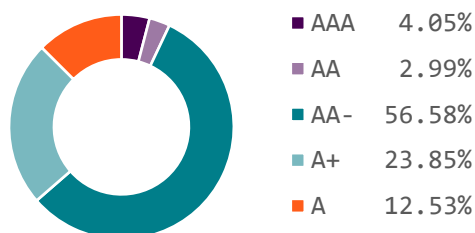

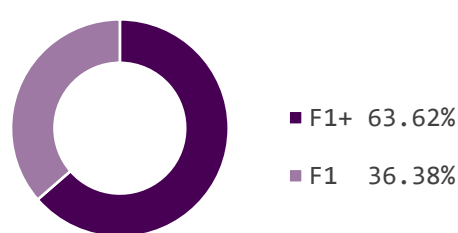

Fund risks
