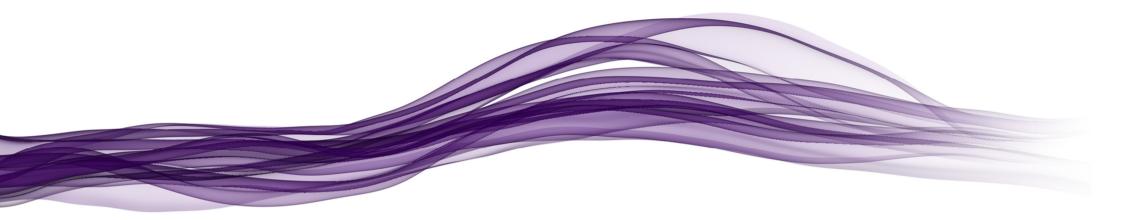

The fund

Fund performance objective and benchmark

The Fund's investment objective is to achieve capital growth over the medium term (3-5 years) by investing at least 80% in the shares of UK companies included in the FTSE All-Share Index. The Fund's performance target is to outperform, after the deduction of charges, the FTSE All-Share Index (the "Index") over a rolling 5-year period. The Index is regarded as a good measure of the share-price performance of the approximately 600 largest companies on the London Stock Exchange. The Index is considered an appropriate benchmark for the Scheme's performance, as the Scheme's potential investments will predominantly be included in the Index. In addition to the benchmark for the Scheme's performance as noted above (the "Index"), the IA UK All Companies sector is considered an appropriate benchmark for performance comparison.

Performance commentary

The first quarter saw another strong performance for risk assets, with several global equity indices reaching an all-time high. Markets were strong driven by hopes that the US economy will continue to experience a soft landing and growing enthusiasm around the opportunities for AI (artificial intelligence). In the US the S&P 500 index was up more than 10% in Q1, meanwhile in Japan, the Nikkei saw its strongest performance since 2009. With that backdrop the FTSE All-Share Index, the UK benchmark rose by 3.6% despite the outlook for domestic growth remaining fairly dull. The best performing sectors included banks and industrials, whilst mining and utilities were the worst.

The Trust outperformed the benchmark during the period under review. The main positive drivers of performance included holdings such as 3I, Next, and Compass. 3I in particular has been a very strong performer over time, reflecting its ownership of the discount chain Action in Europe which continues to grow very strongly. Next and Compass are both good quality corporates and continue to deliver growth and attractive returns for shareholders. The negatives during the quarter included starting the year with no exposure to GSK which bounced strongly on hopes of improved drug productivity. A large exposure to SSE was painful as energy prices fell sharply in January as the winter continued in line with recent trends and was extremely mild and the share price of Close Brothers fell sharply as the FCA initiated a review of historic selling practices in the automotive industry.

Fund activity

Overall, the portfolio remains with a bias towards growth companies, which we believe are mispriced on a long-term basis coupled with an exposure to sectors such as banks and oils which are demonstrating some improvement returns on capital.


During the quarter we established a holding in GSK, part as risk management and part reflecting a low valuation and some positive traction in developing an attractive drug pipeline. The backdrop to the aerospace and defence sector remains positive with a large backlog of orders and as a result we added to Rolls Royce and BAE. Regards reductions we reduced the holding size in Imperial Brands, sold out of BATS and reduced exposure to the mining sector.

Market commentary

Market overview

A key theme to emerge during the quarter was indication of a more favourable global macro backdrop. Despite some mixed signals, the US economy remains resilient, while Europe and the UK show signs of gradually exiting their recessions. Activity in China also seems to be stabilising. At the same time, core central banks are still confident that the disinflation trend remains intact, despite some recent setbacks in inflation prints. Policymakers have often highlighted that they are in no rush to cut rates – with markets now generally pricing the start of the easing cycles to begin this summer. The Federal Reserve, European Central Bank and Bank of England all left interest rates unchanged over the quarter.

One major development over the quarter is that markets have recalibrated their pricing for expected central bank cuts over this year. At the end of last year, markets were pricing in an aggressive rate cutting cycle, but then swiftly move to temper those forecasts. This re-pricing contributed to negative returns for global government bond markets over the quarter. Despite the belief of many that it was the anticipation of a 'Fed-pivot' that contributed to the rally in equity markets in late 2023, equity markets proved to be immune to this bond market sell-off as global growth and business confidence showed signs of resilience and investors focused on the potential offered by AI.

Data continues to suggest that UK inflation is past its peak and that interest rates could ease at some point this year. This has helped to spur UK equities to a relatively strong quarter, with the FTSE All-Share index returning 3.6%. However, investor expectations continue to be somewhat at odds with policy makers, with many expecting cuts to be both deeper and sooner than the monetary authorities are guiding to.

The quarter saw a large amount of corporate reporting which, while mixed, was on balance reassuring. Results from mining companies, housebuilders, building materials companies and more discretionary retailers were relatively weak while financials and industrials made more upbeat reports.

UK market corporate activity has been a notable feature, with a merger between Barratt and Redrow being announced and DS Smith, Wincanton and Spirent among other companies received bid approaches.

Outlook

Inflation data has moderated in the quarter and modest interest rate cuts seem likely at some point in the coming months.

Takeover activity is likely to remain a feature in the UK market as, despite the recent rally, the UK equity market remains relatively lowly valued compared to overseas markets. These relatively depressed valuations also continue to prompt many companies to buy back their own shares.

We believe our approach of investing in a broad range of companies who are in control of their own fates, irrespective of market conditions is the right one. As well as looking for durable businesses, a willingness to look through short-term extremes of sentiment and buy stocks when they are out of favour, or take profits when sentiment becomes exuberant should drive longer term performance.
