**Re: Notice of Updates to the Supplements**

We are writing to you in your capacity as a Shareholder in the Fund(s). The purpose of this notice is to notify you of certain proposed amendments to the Supplements, as further described below. These changes will take effect upon the approval by the Central Bank of the updated Supplements, which is expected to be on or around 17 February 2026.

**SFDR Annex Updates**

It is proposed to update the SFDR annex in each of the Supplements in order to enhance the existing disclosures in respect of (i) how the Sub-Funds promote environmental and / or social characteristics; (ii) related updates in relation to the sustainability indicators for the Funds; (iii) updates to the binding elements section; and (iv) minor clarificatory updates across the SFDR annexes.

In particular, the disclosures will be enhanced to describe how the Sub-Funds promote the environmental characteristic of investing in companies that engage in activities that mitigate climate change or are transitioning to practices which promote climate change mitigation and to describe the types of data and analysis used to determine if a company is aligned with this environmental characteristic.

Further detail on how each company is evaluated has been included in the description of the sustainability indicators used by the Funds, including a description of the Investment Manager’s proprietary,

Related to this enhancement, the description of the binding elements applying to the Sub-Funds have been updated to refer to the specific screening applied to the Fund's investments through use of the Climate Transition Score.

It is intended that 90% of each Sub-Fund's Net Asset Value is invested in securities which are aligned with the environmental characteristic promoted by the Sub-Funds.

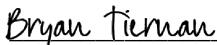
