Unless otherwise indicated, all capitalised terms in this Notice shall have the same meaning as described in the current prospectus (the “**Prospectus**”) of Royal London Asset Management Investment Funds ICAV (the “**ICAV**”) and the current supplements (the “**Supplements**”) for the Royal London Global Senior ABS Fund and the Royal London Global Mezzanine ABS Fund, each a sub-fund of the ICAV (the “**Sub-Funds**”), each dated 22 December 2025 and which are available on the Investment Manager’s website www.rlam.com.

Dear Shareholder

Re: Notice of Updates to the Supplements

We are writing to you in your capacity as a Shareholder of the Sub-Funds. The purpose of this notice is to notify you of certain proposed amendments to the Supplements, as further described below. The proposed updates will take effect upon the approval of the Central Bank, which is expected to be on or around 3 March 2026.

Applications for Shares - Change of Settlement Cycle

It is proposed to update the Supplements to change the settlement cycle for the Sub-Funds with respect to applications for Shares from two Business Days to three Business Days.

Accordingly, the Supplements will be updated to reflect that application monies must be received by the Administrator on the relevant Dealing Day or such other time as the AIFM in consultation with the ICAV may determine and in any event within three Business Days (emphasis added).

Please note that no Shareholder meeting or vote is necessary in connection with the above changes and therefore no action is required by you.
